## **Trucking Injuries**

For many drivers, sharing the road with large commercial vehicles can be stressful and frightening. Tractor-trailer trucks are much larger than passenger cars and trucks, and by law can have up to a total vehicle weight of 80,000 lbs. This means that when commercial trucks collide with other vehicles, the drivers and passengers in these vehicles are likely to suffer serious bodily harm, which may lead to

permanent disabilities or wrongful death.


People who have suffered **personal injuries** in these types of crashes may be able to take legal action against a truck driver, the trucking company that employed them, and the brokerage service that interacted with and directed the truck driver and trucking company. 
